Three Decades of Visionary Leadership

n 1991, Rev. David Beckmann became the second president of Bread for the World, He succeeded Rev. Arthur Simon. who founded Bread in 1974. With his leadership, Bread members have helped expand and shape international development programs and protect our nation's safety net programs.

1991-1999. Bread helped win increases and bipartisan support for the WIC program (nutrition assistance for Women, Infants, and Children). Welfare reform in 1996 included deep cuts to the food stamp program (now called SNAP), but Bread worked with others to restore SNAP food assistance.

Toward the end of the decade, Bread helped convince Congress to increase support for smallholder farmers in Africa. It also established a fund to speed up

the response to food crises.

In the Jubilee campaign to relieve the debts of low-income countries, Bread led the U.S. legislative coalition. With help from Bono, the campaign won U.S. government support for debt relief. Debt relief reduced the obligations of 36 countries by 90 percent, resulting in increased access to health care and public education (especially for girls).

2000-2009. Bread helped to more than double funding for national nutrition

programs. Bread also supported higher nutrition standards for school meals.

In 2001, Beckmann founded the Alliance to End Hunger to engage diverse religious groups, charities, foundations, corporations, unions, and individuals in building the public and political will to end hunger. The Alliance and Bread work together.

During these years, political leaders from the two parties worked together with support from Bread and its

Policy Victories and Organizational Accomplishments in 2019

Bread for the World has been blessed with David Beckmann's leadership for three decades. During that time, our nation and the world have made tremendous progress in achieving God's vision of a world without hunger. David's lifelong dedication to ending extreme hunger reflects both his deep

Bread for the World and Bread for the World Institute continued to focus on our goal of ending hunger through policy change amid challenging U.S. politics. Our history of working on key anti-hunger issues in a bipartisan way and from a position of faith contributed to Bread's credibility and influence.

Global Nutrition

Bread for the World's 2019 Offering of Letters: Better Nutrition, Better Tomorrow campaign achieved broad, bipartisan support for stronger U.S. investments to overcome maternal and child malnutrition.

Bread for the World drafted two Global Nutrition resolutions (H.Res.189 and S.Res.260), which were introduced in the House and Senate in March and June of 2019 respectively. The resolutions recognize the importance of continued U.S. leadership in improving maternal and child nutrition. Bread members and partners recruited a total of 185 members of Congress from both parties as cosponsors of the House and Senate resolutions.

Each resolution passed out of their respective committees with broad, bipartisan support. At the end of 2019, the House resolution passed the Foreign Affairs Committee and is poised for approval by the full House. The Senate resolution was approved unani-

mously by the full Senate in January 2020.

Bread for the World members also helped persuade Congress to increase funding for global nutrition for the second consecutive year — increasing the amount to \$150 million. Congress allocated an additional \$5 million that will allow 50,000 more children suffering from severe malnutrition and 200,000 women with anemia to receive treatment. In addition, Congress increased poverty-focused international assistance overall by \$1.3 billion, or 4 percent, in contrast to the president's proposal for deep cuts to international aid.

Bread for the World Institute worked with the U.S. Agency for International Development to set nutrition priorities for its programs of investment in agriculture, health, and humanitarian assistance.

Domestic and International Poverty-Focused Programs

In 2019, Bread for the World members and partners played a role in seeing that the fiscal year 2020 appropriations agreement included a substantial increase for domestic safety-net programs — the first increase since 2010. The biggest increases went to low-income housing and education for low-income children. Child nutrition programs were funded at \$474 million, providing meals for an estimated 31 million children. For the first time, the

advocacy partners to triple funding and improve the quality of povertyfocused international assistance. This increased funding contributed to unprecedented progress against hunger and poverty around the world.

President Bush proposed the Millennium Challenge Corporation, which aids low-income countries that practice good government. Bread provided leadership in winning bipartisan support. Bread also helped pass the Africa Growth and Opportunity Act to promote Africa-U.S. trade.

The end of 2008 brought a world food crisis as well as an international financial crisis. Bread supported President Obama's leadership of international investment in smallholder farmers in low-income countries and helped convince the administration to include nutrition in their initiative.

2010-2019. The elections of 2010 led to a massive, multi-year push to cut funding for nearly all

WIC Breastfeeding Program received enough funding to staff peer counselors in every WIC agency across the country.

The budget agreement also mandates that poverty-focused aid to Central America and food security aid worldwide must be disbursed — and not rescinded by the administration.

Criminal Justice Reform

Bread for the World believes that reforming our nation's criminal justice system is critical to ending hunger and poverty in the United States. In 2019, Bread continued its work on the First Step Act, which passed in the House and Senate with strong bipartisan margins in December 2018. The First Step Act reduces mandatory minimum sentences for nonviolent drug offenders and gives judges more flexibility in sentencing. The legislation provides for education, training, and treatment programs to help people successfully re-enter society.

Bread for the World met with Department of Justice officials and congressional leadership to urge robust funding and equitable implementation of the bill. The fiscal year 2020 budget agreement fully funds the First Step Act and provides increased funding for Second Chance re-entry grants. These grants will help organizations continue to provide education and employment training programs for individuals who were formerly incarcerated.

2019 Advocacy Summit

More than 300 people participated in a two-day Advocacy Summit and Lobby Day on June 10-11. In 176 meetings, participants urged their members of Congress to co-sponsor the global nutrition resolutions and increase funding for global nutrition.

The event included a convening of 84 Pan-African/African American and 44 Latino leaders to learn from each other and raise their distinct voices against hunger and poverty. A reception and book launch for Rev. Arthur Simon, Bread for the World's founder and president emeritus, was held to celebrate the release of his latest book, *Silence Can Kill: Speaking Up to End Hunger and Make Our*

poverty-focused programs. Beckmann co-founded the Circle of Protection, a group of religious leaders from a broad array of faith traditions, who have worked together to urge Congress to support poverty-focused programs. Despite repeated budget brinkmanship, no substantial cuts to low-income programs have taken place.

Thanks to a bipartisan coalition of members of Congress, along with the advocacy of Bread and its partners, international aid continued to increase

throughout this decade. Bread pushed successfully for reform of food aid so that more food can be purchased locally, making that aid more timely and cost-effective.

Progress against world hunger inspired Bread to focus on the feasibility of ending hunger by 2030. In 2015, during Pope Francis' visit to the United States, our government joined other nations in adopting the Sustainable Development Goals, calling for an end to extreme poverty and hunger by

In 2019, Bread members generated 95,000 high-level advocacy actions—all urging members of Congress and the administration to support policies and programs that will bring us closer to the end of hunger.

Economy Work for Everyone. During the evening program, Bread activists Edith Avila Olea and Barbara and Rev. Bud Miller received the Rev. Arthur Simon Award for Faithful Service to End Hunger.

Election Work

By the end of 2019, all the Democratic candidates for president were talking about what they would do to reduce poverty — a shift from little explicit mention of poverty in recent election cycles. Bread for the World and Circle of Protection partners contacted each of the Republican and Democratic presidential primary campaigns and secured video statements about hunger and poverty from eight candidates. The Circle of Protection — composed of heads of Christian denominations, organizations, and institutions — urges our nation's leaders to give priority to alleviating hunger and poverty.

Bread promoted the video statements in emails and digital ads to more than 110 million voters and urged them to focus on hunger and poverty as an election issue. More than 750,000 people viewed the candidates' videos.

2019 Hunger Report

Bread for the World Institute's 2019 Hunger Report, *Back to Basics: How to End Hunger by 2030*, was launched in late August. The report makes the case that ending hunger is feasible and shares stories of advocacy. It discusses five key issues



that are part of the solution: nutrition, jobs, gender, climate change, and fragility in nations and communities marked by hunger and violence.

Applying a Racial Equity Lens to End Hunger

Bread for the World Institute continues to share its research on the relationship between hunger, poverty, and race in the United States. In 2019, the Institute released a special report, Applying a Racial Equity Lens to U.S. Federal Nutrition Policies: SNAP, WIC, and Child Nutrition. The report outlines policy recommendations that will improve the impact of national nutrition programs, specifically in communities of color.

The Institute also utilized its Racial Wealth

2030. Beckmann travelled to Rome and met with Vatican officials twice in the run-up to the Pope's visit.

In 2016 and again in 2018, Bread played a leadership role in passing the Global Food Security Act, which has continued the U.S. food security initiative during the Trump adminis-tration. In 2017, Bread played a key role in gaining an appropriation of \$1 billion in famine relief for Yemen, Northern Nigeria, South Sudan, and Somalia.

In 2018, Bread worked with many other groups to defeat a proposed \$1 trillion cut in Medicaid. This result led to increases for safety-net programs in 2019, the first increases since 2010.

In 2019, Bread helped create and secure co-sponsors for the Global Nutrition Resolutions in the House and Senate. It achieved broad, bipartisan support for stronger U.S. investments to overcome child malnutrition around the world.

Activists in Action

Indiana

During the 2019 August congressional recess, Bread for the World members across the country visited lawmakers in their home districts.

On August 22, nearly 350 Bread for the World members and others representing 37 cities and towns in Indiana gathered to hear Sen. Todd Young (R-Ind.) state his support for increased global and domestic nutrition programs.

"Working on global hunger and food insecurity is both a national security issue and a moral imperative for the United States," Young said. "With the support of hundreds of concerned Hoosiers with Bread for the World, I've been able to use my position on the Senate Foreign Relations Committee to elevate these humanitarian issues. I look forward to continuing to partner with [Bread for the World]."

Like Senator Young, many members of Congress spent more time in their home states and districts as part of the summer recess. Bread for the World members organized 121 meetings and other in-district actions over an eight-week period.

Idaho

In early November 2019, 160 anti-hunger advocates crowded into a room in Boise's Idaho History Museum to hear Sen. Jim Risch (R-Idaho) talk about foreign aid. The Idaho Cares about Foreign Affairs Luncheon was sponsored by Bread for the World, Oxfam, Save the Children Action Network, CARE USA, and the ONE Campaign.

Bread for the World board member Dawn Pierce asked Risch about the Global Nutrition Resolution. Pierce knew Risch had already cosponsored the resolution, but as the

Republican chairman of the powerful Committee on Foreign Relations, he sets the committee agenda and his support to pass the bill out of committee was vital.

In response to Pierce's question, Risch said he would take the next step to advance the bill. "I'm going to put that bill on the next business meeting of the committee," he said. In pledging support for this measure, Sen. Risch

noted the extreme poverty he saw on his recent travels to Africa, stating, "There's nothing — these kids have nothing."

The resolution passed in committee by unanimous voice vote on December 11, 2019. "Senator Risch kept his word and did what he promised he would do," said Pierce, expressing her gratitude for his leadership.

Clark Hansen, who leads Bread's fieldwork in Idaho, helped organize the event. He was thrilled to see a locally organized event move legislation in Washington, D.C., and he attributes the success to partnering with likeminded organizations at the community level.

Nearly 750 leader activists and 48 active Bread teams demonstrated leadership in making in-district advocacy happen in 2019.


