Bread for the World Institute's 2018 Hunger Report, The Jobs Challenge: Working to End Hunger by 2030, was launched in April at the National Press Club. The report highlights the role that a well-paying job plays in reducing hunger and poverty. It lays out a menu of policies that would improve job opportunities for Americans who are struggling with hunger and poverty. The last chapter of the report argues that jobs issues are also crucial to progress against hunger and poverty in developing countries and outlines how advocacy on domestic opportunity and international development are mutually reinforcing. In May, the Institute hosted an event entitled, "Applying Racial Equity

Bread for the World Institute received grant funding to expand grassroots advocacy capacity in the southeast region, by recruiting and supporting Bread leaders and teams in Florida, North Carolina, South Carolina and Tennessee. For example, in Florida, two new Bread teams were formed in Tampa and Jacksonville and 17 in-district meeting took place across the state during the August congressional recess. In North Carolina, regional and statewide advocacy trainings reached more than 200 constituents and 45 members assumed leadership roles in Bread teams across the state.

Bread for the World Institute continues to push for a prioritization of global nutrition programming within the U.S. government. In September, the Institute hosted a Faith Leader Consultation for Global Nutrition in September. This consultation brought together 30 Christian leaders from 13 states to deepen their engagement with advocacy on global nutrition. Participants met with key USAID officials and congressional staff, shared stories about advocacy, and developed new skills and joint strategies for future advocacy. The consultation was followed with lobby visits seeking a \$20 million increase for global nutrition in the fiscal year 2019 spending agreement.

to Hunger and Poverty", which included featured speakers from the Annie E. Casey Foundation, Congressional Hunger Center, Alliance to End Hunger, Prosperity Now, and Policy Link. The event also launched the Racial Wealth Gap Learning Simulation, a new interactive tool that helps individuals understand the connection between racial equity and hunger. Staff have been invited to present the simulation to Congressional staff in the Senate and House. The simulation has also been an effective tool for organizing and educating Bread members. In March 2018, the Institute published updated state fact sheets on U.S. hunger and poverty numbers. The Institute published three papers related to the Farm Bill: fact sheets on SNAP, food aid, and a background paper about nutrition in food aid. The Institute also released a paper on mass incarceration and hunger that will be critical as the House and Senate prepare sentencing and prison reform proposals, and one on Feed the Future to use in our advocacy for the Global Food Security Act.

Bread for the World Institute continues to monitor and provide input, through the Modernizing Foreign Assistance Network and other coalitions, into USAID Administrator Mark Green's plans to reorganize the agency around the goal of helping countries get to the point where they no longer need aid. This "journey to self-reliance" means a greater focus on strengthening local capacity, mobilizing domestic resources for development, and bridging the gap between humanitarian

and development assistance. USAID's proposed reorganization expands the Food Security Bureau to include programs to strengthen community resilience to drought and other adverse developments. This expanded unit will be grouped with humanitarian and conflict-avoidance programs and will report to an Associate Deputy Administrator, who will be able to represent these concerns in high-level government meetings on national security issues.

The Institute continues to work with partners on an advocacy strategy to achieve a targeted, scaled-up U.S. effort to accelerate progress toward the 2030 nutrition goals and a strategy to urge the World Bank to allocate additional funding to nutrition.
